- 3. While generally guided by statute, judges do have considerable discretion in the area of criminal justice sentencing. Depending upon their philosophies, judges may exercise the discretion to promote criminal rehabilitations, the protection of society, and deterrence of other criminals.
 - a. Could you characterize your own views on how this discretion ought to be exercised?

Judicial discretion must always and unequivocally be applied in a fair and impartial manner in order to guarantee the equitable treatment of all individuals who appear before the court. In most criminal cases, a judge should exercise his or her discretion while contemplating each of the enumerated goals referenced above: rehabilitation, the protection of society, and deterrence. In determining and imposing a reasonable, appropriate, and just sentence, a judge must also seek an outcome that is commensurate with the nature of the offense, the culpability of the defendant, and the harm caused to the victim or the community. Although often described as competing interests, I view the three sentencing goals listed above as generally complementary to one another, and I therefore believe that a judge must consider each basic objective while relying on wisdom, fairness, and the good judgement developed through judicial experience to ensure the facilitation of well-reasoned, equitable, and impartial sentencing decisions.

In the district court, where the cases tend to be less serious and where the offender's criminal history is also likely to be less violent or repetitive and where fewer minimum sentences are mandated, the opportunity for effective rehabilitation is paramount. If an offender is held accountable and justly sentenced for his or her crime, that offender may be deterred from committing the same or similar crimes in the future. If an offender is successfully rehabilitated as a result of the administration of the sentence, his or her likelihood to reoffend is reduced, which consequently enhances and promotes public safety. The safety of the public is not necessarily protected through incarceration. In fact, custodial detention should be used only as a last resort if a less restrictive alternative would not be appropriate. These sentencing philosophies are not mutually exclusive, and they can serve as guiding principles in each individual case.

I believe that just and proportionate sentencing could deter others from committing similar offenses, but I do not think that the use of harsh sentencing as a deterrent should be an overarching or primary goal in sentencing any individual defendant, because it could unfairly infringe on the ability of that defendant to receive fair, impartial, and appropriate treatment under our law. We should not use highly punitive sentencing with any individual to "make an example" of that person as a means of "sending a message" to others. The implication that similar offending behavior will be met with the strictest of penalties without regard to the facts and circumstances, including mitigating and aggravating factors and the culpability unique to any individual offender, does not comport with the concept of justice. I believe that, where statutorily permitted, a judge should exercise his or her discretion in a thoughtful manner consistent with individualized, evidence-based sentencing practices and administer justice fairly and impartially, with compassion and the utmost integrity.

 - If I am fortunate to receive a judicial appointment, I would not support further limits on such discretion through legislation. However, I would act in accordance with the law if such limits were to be imposed through legislation.
